## 5. Examination of Candidate Christopher L. Bouma

a. Andy Geelhoed from Ideal Park CRC provided an appropriate introduction

b. Rev. Jim De Zeeuw conducted the **Practica** portion. Opportunity was given for further questions and a motion to proceed carried.

c. Rev. Mike Hoogeboom read and expanded upon the **Sermon Critics Report** reflecting his and Rev. Paul Sausser' attendance at the assigned sermon's preached at Ideal Park and evaluation of the two other sermons submitted as required. They moved to proceed. After opportunity for discussion the motion passed. The Synodical Deputies concurred.

d. Rev David Struyk conducted the **Biblical Theological** portion as required. Opportunity was provided for all present to ask additional questions.

e. Executive session was declared and a motion to admit candidate Christopher L. Bouma into the ministry of the Word was made. Ron Kool led in prayer and discussion followed.

The Synodical Deputies were excused to arrive at their decision while classis voted by ballot which resulted in a unanimous approval of the motion to admit the candidate.

f. Upon their return and being informed of Classis' decision, the Synodical Deputies indicated their written concurrence. (Documentation will be sent to Synodical Services.)

g. Executive session was concluded, the candidate and others present were invited to return. The decision to admit was announced and received with joy and gratitude. Congratulations were given. The stated clerk presented the Classical Diploma and a Certificate of Ordination. The delegates surrounded Chris and Elizabeth Bouma as Rev. Curt Walters led in a prayer of praise and thanksgiving, concluded by singing "Praise God from Whom All Blessings Flow...."

h. Related information:

The Service of Ordination and Installation at Ideal Park CRC was set for August 25, 2019. Rev. Ed Visser will represent Classis Grand Rapids South. Regional Pastor, George Vink, in consultation with Pastor Resources and Chris Bouma will assign a mentor as required.
