1.Code of Conduct Discussion- Dr. Amana Benckhuysen led a discussion as requested by Synod after having delegates read the Code as presented. She reviewed its history and need as well as sought input regarding how the Code could improve people's ministry and how best to implement the Code's provisions at the local level.

- **4.Denominational Representatives** Laura Keeley from Faith Formation shared information regarding available resources. Carla Bieber from Connections presented a page of ways to connect. Amy Schenkel from Resonate spoke regarding local efforts to maximize outreach.
